

This Agreement is made and entered into this Monday, 24/4/2022, in the Emirate of Sharjah, United Arab Emirates, by and between:



#### Preamble

Based on the keenness of both Parties to support and enhance community development, and to achieve the concept of partnership between the public sector and the private sector aiming at joining the efforts to serve the community in general and the members of the Department of Social Services in Sharjah in particular, as well as to serve and advance this category of society, the two Parties are desirous to achieve societal partnership with steady steps and effective visions, to conclude an Agreement (Sanad) to grant the members of the First Party discounts and special services through the Second Party.

#### Article I

The above Preamble shall be an integral part of the terms of this agreement and shall be read and interpreted as per its provisions.

#### Article II

This article clarifies the definitions of the terms contained therein, as follows:

- Sanad Contract: It is a contract entered between the First Party and the Second Party to carry out a joint action aimed at providing support to the First Party's members, including services or discounts.
- Sanad Card: It is a card issued to the employees of the First Party, and holders of this card shall enjoy the benefits provided by the Second Party, and they can use the same benefits of the Card for themselves and their families who represent them as the member may be an elderly, bedridden, child or a person of determination.
- Members: They are all cases registered at the First Party as social assistance recipients of low incomes.

#### Article III


#### **Obligations of Both Parties:**

Both Parties have agreed to cooperate with each other to achieve the following goals:

- Providing all forms of solidarity with the cases registered at the First Party, as they are cases of priority for social care, raising their standard of living, and improving their quality of life.
- Supporting the institutional cooperation to achieve social solidarity and social responsibility.
- Promoting and consolidating human values and charitable work in the society.
- Cooperating with each other to provide social support to vulnerable groups.

#### Article IV

#### Obligations of the Second Party:

- 1. Offering a discount of 20 % to Sanad Card holders.
- 2. Dealing with Sanad Card holders in a courteous manner in terms of the priorities and discounts to be enjoyed with or the fees to be paid as specified on this card.
- 3. The Second Party shall place the discount poster at the sale outlets agreed upon (shall be provided by the First Party when signing the Contract).
- 4. Submitting an annual report on the beneficiaries of this agreement.

#### Article V

#### Obligations of the First Party:

- 1. Announcing the agreement to its members by the appropriate channels.
- 2. Announcing the Second Party in the periodical Magazine and the First Party's website.
- 3. Granting the Second Party a certificate of gratitude and appreciation at the end of each year, based on the report received from the Second Party at the annual ceremony.

#### Article VI

This agreement shall be valid for two years starting from the date of signing hereon and shall be automatically renewable. Either Party may terminate this Agreement vide at least one-month prior notice served to the other Party. None of the terms of this Agreement shall be amended without a written consent of both Parties.

#### Article VII

If there is any change in the working circumstances of either Party that would affect the implementation of this agreement, the two Parties may amend the same in accordance with the new circumstances of each Party, provided that the amendment shall be in writing and takes effect after its approval by the two Parties.
